

## Target Market Determination

**Made by:** McLaren Minerals Limited (ACN 163 173 224) (**Company**)

**Product:** Options to be issued under prospectus dated 4 November 2025

### Important information about this document

This target market determination (**TMD**) has been prepared by the Company in relation to the following offers (together, the **Offers**):

- (a) (**Entitlement Offer**): the offer of free-attaching options to acquire Shares, comprising of Short-Term Options, each exercisable at \$0.0224 and expiring on the date that is 15 months from the date of issue, and Long-Term Options, each exercisable at \$0.035 and expiring on 5 February 2028, to Eligible Shareholders pursuant to a non-renounceable pro-rata entitlement offer of New Shares;
- (b) (**Top-Up Facility**): the offer to Eligible Shareholders to subscribe for Top-Up Securities in excess of their entitlement, pursuant to the Entitlement Offer;
- (c) (**Shortfall Offer**): the offer to professional or sophisticated investors identified by the Company in reasonable consultation with the Underwriter to subscribe for any remaining Shortfall under the Entitlement Offer and Top-Up Facility; and
- (d) (**Sub-Underwriter Offer**): the offer of Long-Term Options to be issued, subject to Shareholder approval, to various Sub-Underwriters (or their respective nominees) appointed by the Underwriter to sub-underwrite the Entitlement Offer on the basis of one (1) new Long-Term Option for every two (2) New Shares sub-underwritten,

(collectively the **Options**), pursuant to the Company's prospectus (available at <https://mclarenminerals.com.au/>) dated 4 November 2025 (**Prospectus**).

Capitalised terms used, but not defined, in this TMD have the meaning given to them in the Prospectus.

By making an application under the Offers, you warrant that you have read and understood the TMD and that you fall within the target market set out in this TMD.

Any eligible recipient of this TMD should carefully read and consider the Prospectus in full and consult their professional adviser if they have any questions regarding the contents of the Prospectus. Any recipient of this TMD who, being eligible, wants to acquire Options under the Prospectus will need to complete the relevant Application Form. There is no cooling off period in respect of the issue of the Options. This TMD is not a disclosure document for the purposes of the *Corporations Act 2001* (Cth) (**Corporations Act**), and therefore has not been lodged, and does not require lodgement, with ASIC.

This TMD does not take into account what you currently have, or what you want and need, for your financial future. It is important for you to consider these matters and read the Prospectus before you make an investment decision. The Company is not licensed to provide financial product advice in relation to the Options.

| Investment timeframe | <p>The target market of investors will take a short to medium term outlook on their investment.</p> <p>The Company will not apply for quotation of the Short-Term Options under the Prospectus. The Short-Term Options are not transferrable (except with prior written approval of the Company and subject to compliance with the Corporations Act and the ASX Listing Rules) and are therefore not suitable for investors looking to trade the Short-Term Options prior to their exercise.</p> <p>The Company will apply for quotation of the Long-Term Options subject to compliance with the requirements of ASX and the ASX Listing Rules. To the extent the Long-Term Options are quoted on ASX's official list, the Long-Term Options will be freely transferable from the date of issue. However, investors (particularly those with a medium term outlook for their investment) should be aware that, to the extent the ASX conditions to quotation are not satisfied, the Long-Term Options will not be issued.</p> <p>Option holders will also have an ability to exercise Options and trade the underlying Shares issued on exercise (irrespective of whether or not the options are quoted), however, investors should be aware that such a dealing is only likely to be commercially viable in the event the trading price of the Shares exceeds the exercise price of the Options both at the date of exercise and sale.</p> <p>Investors with a short to medium term outlook will benefit from an ability to exercise the Options within the 15-month term of the Short-Term Options and the approximate 27-month term of the Long-Term Options and increase their shareholding and exposure to the potential upside in the Company's Shares into the future.</p> <p>Given the need to pay the exercise price in order to acquire the underlying Shares, investors in the target market are those who are in a financial position that is sufficient for them to invest their funds over a 15 to 27 month time horizon, during which time their ability to liquidate their Options may be limited on exercise of the Options by the trading price of the underlying Shares.</p> |
